PROPOSED CONSTITUTIONAL AMENDMENTS

2013 AGM



Over the last year, the C.M.C has reviewed the constitution and based on issues raised by members of the club and current circumstances the following amendments to the TTGAC Constitution are being proposed so as to ensure that the constitution continues in a more robust form. Under clause 26.01 of the constitution we require a majority of three quarters of the members present (either personally or by proxy) to approve the changes to the rules at a General Meeting.

The following motions will be moved as a whole at the meeting.

Motion 1

Athletics Association of SA is now referred to as Athletics South Australia. Sections 1.01, 3.01.b, 4.0.1.a and 17.0.1.c are affected. Propose that section 1.0.1 be amended as follows (and other affected sections updated accordingly):

“A.A.S.A.” means the Athletics Association of South Australia.

Replaced by:

“A.S.A.” means Athletics South Australia.

Motion 2

The C.M.C would like to recognise those members who have contributed in the capacity of athlete as well as for service to the club by amending the life membership criteria as follows:

8.01 Life membership may be bestowed upon any person who has rendered outstanding and valuable service to the Association. A minimum of 10 years service of the Centre or its Predecessor before Life Membership is considered.

Replaced by:

8.01 Life membership may be bestowed upon any person who has rendered outstanding and valuable service to the Association. Life membership will be considered when the member has provided either:

(a) A minimum of 10 years of service to the Centre or its Predecessor; or

(b) A minimum of 15 years of service to the Centre or its Predecessor as either a competing athlete and/or provision of service to the Association.

Motion 3

The C.M.C proposes that an additional clause be included under subscriptions section 12.0 as follows:

12.03 Any member whose subscription is outstanding for more than three months after the due date for payment shall cease to be a member of the Association, provided always that the committee may reinstate such a person’s membership on such terms as it thinks fit.

In addition, clause 14.01.a is to be removed.

14.01 The C.M.C. may expel any member of the Association:-

(a) Whose subscription is in arrears for more than two (2) years after it became due and payable;

Motion 4

Correct grammar in clause 15.02 last paragraph from:

Such a meeting shall be convened not less than twenty eight (28) days nor more than forty two (42) after receipt by the Secretary of such request and if the case of a requisition by members the meeting is not convened within the time specified above the requisitionists may be resolution appoint one of their member to convene such a meeting.

to

Such a meeting shall be convened not less than twenty eight (28) days nor more than forty two (42) after receipt by the Secretary of such request and if the case of a requisition by members the meeting is not convened within the time specified above those requisitioning may by resolution appoint one of their member to convene such a meeting.

Motion 5

The C.M.C proposes the following inclusion to section 17.01 to cater for instances where insufficient representatives from either Little Athletics or Senior Athletics are represented on the C.M.C:

(k) If the criteria in 17 (j) is not met by either party, then that party shall nominate an additional representative from amongst their members to reside on the C.M.C.

Motion 6

The C.M.C proposes to update section 17.09 as follows:

17.09 The C.M.C. shall hold meetings at least once every 3 months and minutes of all resolutions and proceedings of the C.M.C. shall be entered in a book to be kept for that purpose.

Replaced by:

17.09 The C.M.C. shall hold meetings at least once every 3 months and minutes of all resolutions and proceedings of the C.M.C. shall be recorded and filed in a folder kept for that purpose.

Motion 7

The C.M.C propose that section 17.10 be amended to cater for (a) the possibility that one group or the other may not be able to affiliate with their respective peak body and (b) increase the number of general committee members as follows:

17.10 At every Annual General Meeting, elections shall be held for positions on two sub-committees vacated by retiring members. The Sub-committees shall be known as "Tea Tree Gully Little Athletics Centre Committee" and "Tea Tree Gully Senior Athletics committee" and each shall hold affiliation with their respective peak bodies (SALAA & AASA). The Sub –Committees shall comprise the following members:-

Motion 8

The C.M.C proposes that the TTGAC end of financial year be changed from 31st March to the 31st December so as to allow sufficient time for the books to be audited given that the AGM is now planned for the end of the summer season. As such it is proposed that section 23.00 be amended as follows:

23.00 ACCOUNTS

23.01 The financial year of the Association shall end on the 31st March in each year.

23.02 The C.M.C. shall cause to be prepared audited and printed every year a Profit and Loss Statement, Balance sheet and other accompanying accounts. The said Balance Sheet shall be prepared as at and the other accounts shall cover the year ending on the said 31st March in each year.

23.01 The financial year of the Association shall end on the 31st December in each year.

2013 TREASURER'S REPORT

This year has been an exceptionally good year for the club. We have had many new Sponsors both monetary or with the donation of goods to a dollar value. Our Little Athletics registrations have had a big increase, as have our Seniors which is good to see.

As per usual, there is not sufficient time between the end of the reporting year (31st March 2013) and the AGM to have the accounts audited, hence the attached accounts are unaudited at this stage. The audit will be done shortly and any changes required by the auditors will be undertaken. The 2011/2012 financials were audited after last years AGM without any changes.

Tea Tree Gully Little Athletics has had a huge year. Registrations were up and uniforms were busy again with many new athletes needing them as this season saw the old uniform finally phased out. Due to an impressive increase in athletes we encountered delays at events and long waiting times. So the decision was made to purchase a new high jump mat, uprights and a fibre glass cross bar, and a new portable discus net and pegs etc. The problem is now under control and was a well needed purchase.

The Tea Tree Gully Seniors registered athletes increased slightly from last year. The Pro Meet as usual was a positive for the Tea Tree Gully Seniors and they managed to raise the funds to cover the meet. New uniforms were purchased for the Senior Athletes and are starting to sell, so look out for our snazzy athletes in 2014!

Centre Management hall/oval hire is up slightly. The kitchen area has had a huge upgrade with 2 new upright freezers being purchased as well as new display shelving on its way. The Centre Management committee made a decision to increase hall hire cost to keep in line with other venues and as it hadn't been addressed in many years it was time to do so.

We continue to have several schools use our facilities for their sports days as well as have the Little Athletics club run the canteen on these days. The profit that the centre makes from running a canteen for these schools is extremely profitable so it is well worth the effort of making sure this continues. (note that the huge increase in canteen profit is not due to more hungry kids, but we have had two SAPSASA/ High school days in one financial year) We thank our members for volunteering on these days. I would especially like to thank Leanne Norbury, who isn't here tonight for doing a fantastic job over the last 4 years, in both running the hall hire, running the canteen on school days and liaising with the schools to keep them happy and coming back. A job very well done!

The term deposits since 12th March 2012 have provided an interest income of \$3608.08, of which \$2608.08 has been reinvested. The CMC granted the Little Athletics club \$1000 to assist in the purchase of new high jump bags to help the problem of waiting times due to an increase in athletes this year. The interest rates have not been as favourable this financial year and are currently sitting at 4.10%.

A chocolate fundraiser was held early this year and was a huge success for the club with a profit of \$2637 to date. Thanks to all who took part in this.

Overall the club is in a strong financial position but, as usual, highly dependant on the voluntary helpers and fundraising efforts which need to continue to maintain this position. I hereby present the Treasurers Report complete for 2012/2013. I ask that it be accepted as presented pending a full audit.

2013 LITTLE ATHLETICS PRESIDENT'S REPORT

Season 2012/2013 saw a large influx of numbers with a total of 277 registered athletes, up from 218 last season and 122 were first time registrations. Many of the younger age groups had 15 or 20 athletes and due to these numbers, the committee effectively minimised waiting times by:

- Suspending the acceptance of any more registrations after December
- Purchasing another portable discus ring and net, as well as a fourth High Jump bag.

One of the positive attributes and “selling” points of TTGLAC is the tremendous coaching team consisting of 6 accredited coaches over summer and one very dedicated John Bos providing cross country training over winter. Training started well at the beginning of the season with a good number attending, but dropping after the Christmas break. We held a “C” grade officials course and also a Level “0” coaching course, but considering the large number of families we had on the books this year, numbers attending were disappointing. We hope to continue to offer these and that more parents of TTG athletes take advantage of these courses.

The committee faced a few difficulties throughout the season, with no secretary having been appointed and some committee members resigning during the year. Sadly our President, Jim had to stand down after Christmas due to health reasons. Unfortunately nobody was willing to take over the Presidency, so on advice from the Centre Management Committee, a Proxy President was appointed, with the duties of Secretary and President divided up amongst the remaining committee. We fortunately have had two new committee members join during the season to share some of the load.

For fund raising this year we sold the Cadbury Chocolate boxes which proved to be a fantastic earner and we thank all of you who sold boxes and promptly returned your monies.

The 2012/2013 season has been a year of rebuild for the Senior Athletics Club with a focus on increasing membership, athlete participation at interclub and state events, a pathway for little athletes to senior athletes and putting together a senior committee to oversee and achieve a successful senior club. The first priority was to form a senior committee who would meet regularly and put in to place processes that would increase membership, participation, resources and improve coaching and training opportunities, not only for this season but future seasons.

Over its short history the Tea Tree Gully athletics club has achieved great success and we would like to see that continue in the future. As recently as the years 2003 to 2007 The Senior Club won open men / women and underage premierships, had athletes (Mark Ormrod, Katrina Webb, Tania Van Heer) competing and winning Olympic, Paralympic and Commonwealth Games medals. The club then reduced to a small number of athletes competing and our goal as a group is to bring the senior club back to a strong presence in SA Athletics.

At the State Relay Championships a small team of athletes including 2 Little Athletics Club members had great success winning three medals from four events.
