

## PRESIDENT'S REPORT 1989/90

During the 1989/90 Athletics seasons the Centre had a very successful year. The performance of Tea Tree Gully Athletes in both individual and team competition continued to show high standards and commitment.

The performance of the Senior athletes in the summer inter-club competition is a fitting reward for the effort of many coaches, competitors and supporters over the last 12 years to establish Tea Tree Gully as a recognised force in South Australian senior athletics.

Tea Tree Gully Athletics Centre continues to be a dominant force in the South Australian and National Little Athletics scene. The provision of an atmosphere where beginners can try at athletics, others can develop athletics skills and where others can excel in state and national competitions is difficult but Tea Tree Gully Little Athletics manages to maintain an effective balance between these sometimes conflicting demands.

I would like to thank the many members of the Centre who have made an effort to help athletics in the Tea Tree Gully area. The members of the Centre Management Committee and the two major subcommittees deserve special thanks for the manner in which they have worked during 1989/90.

## LITTLE ATHLETICS PRESIDENT'S REPORT.

In the early part of the season the club ran a C & D Grade Officials course for parents and athletes in the older age groups. In the week following the course we had a total of 6 parents and 3 athletes who sat for and successfully passed the examination.

We also had the privilege of having 4 of our parents sit for their "B" Grade badges and I am pleased to advise that 2 parents have successfully gained their badges while the other 2 have passed their theory section with flying colours.

Their practical exam. will be held next season. We now have "B" Grade Officials in all areas except Timekeeping, but that will be rectified next season.

Unfortunately it has taken until the end of the season to attract enough parents willing to become coaches, however, we will be holding a course during the winter season. Hopefully, this will allow us to have quite a few coaches at the start of next season.

At the State Relay Championships in December the Centre won the Team Trophy for the 7th consecutive year with individual teams winning 6 Gold, 7 Silver and 3 Bronze medals.

Having won the Peter Fullager Walks Trophy last season, we unfortunately lost it this season, by a very small margin to Munno Para. On an individual basis, 12 athletes took medals (4 gold, 5 silver, 3 bronze with 1 S.B.P. set).

For the 3rd consecutive year the same number of athletes (75) qualified to compete in the State Individual Championships and they won a total of 33 Gold, 23 Silver and 21 Bronze medals.

The Centre was honoured to have 3 athletes represented in the State Team that went to Hobart. They were; Lara Kara-Ali (Under 12), Andrew Gooch and Luke Menzel (Under 15 team). Unfortunately, Luke was unable to go as a result of an accident. Lara and Andrew accredited themselves with outstanding performances in their age groups and congratulations to Lara for gaining a Silver medal in the 1500m walk.

State Best Performances were equalled or bettered by 5 athletes (4 girls and 1 boy) and Centre Best Performances were equalled or broken 26 times during the season (11 times by boys, 15 times by girls).

Registrations for the year totalled 188 (10% down on last year).

The end of season break-up and trophy night was held on April 22nd. The hall was almost filled to capacity but the numbers were down on last year's break-up. The medals and trophies were well received by the athletes, and judging by comments I received the evening was enjoyed by all.

Finally, I would like to congratulate every athlete on their achievements throughout the season, whether it be personal best, centre best, state best or just competing for the enjoyment. Also I would like to thank all the people who volunteered their time in the various aspects of running the club. The continued success of the club is largely dependent on the work done by the athletes, coaches and officials.

## 1989-90 SENIOR CLUB REPORT

This season has been a particularly successful one for the senior club. We were off to a good start with more than 20 athletes registering for the first Association winter relays at Patawalonga, and although not a strong winter club, we contested all Association winter relays, possibly the best team performance being in the City-Bay, achieving an excellent average time of approximately 41 minutes.

Seven teams competed in track & field. They were; - women; senior; U18; U16; and men; senior & grade and O grade; U18; U16. Three of the teams, the U/18 women, U18 men and senior men & grade, won their respective premierships. In all cases the teams included athletes from younger age groups, some of them competing the finals in events they had not previously performed. Whilst not to detract from the performances of our senior athletes, some of which were heroic in endurance events, the most encouraging sign must be the enthusiasm & consistency of the U/16's & U/18's. To have such a wealth of talent in a time bracket of approx. 3 years, mostly via our hitle Aths, has never previously occurred since the senior club formed in 1975.

We are once again an A'grade club (sorry ladies, but clubs do get categorised by their senior mens grading) We must try to consolidate that position in the coming Season so that our improving U/18's can compete at the top level without having to change clubs.

The women do not have the same problem, as they are graded for competition irrespective of club. However, we could have a problem in that the first U/18 to reach 18 may find herself a one woman team, & we would not wish to weaken the successful U/18's by too much poaching. I am certain some of the athletes mums would enjoy competing and could successfully hold the fort "while more of our U/18's reach 18. Now is the time to consider it, not the Start of the next track and field season.

On the administrative side, the club has once again survived without a full committee. The social secretary position has been vacant for the past 2 or 3 years. If you are interested do not he situte to nominate at the AGM. My thanks to last years

committee, all of whom are willing to continue in the coming year. Thanks also to the coaches, team managers, 05F officials and people who have helped at our social functions.

Finally, congratulations to all athletes who were ultimately responsible for making this season such an outstanding success. Carry on the good work next season.
