PRESIDENT'S REPORT - TTG Senior Athletics

Season 2006/2007 interclub was split into two separate competitions with the requirement to finish in the top two in one of the seasons to qualify for finals.

In the first half the Open, U20, U18 and U16 men all qualified. The second half, Chris Roberts drew on all of his resources to enable the U20 women to qualify. The Over 35 men had a big fight on their hands but with outstanding commitment and determination from a small group, managed to finish top, enabling them to compete in Interclub finals.

Interclub finals saw the U20 women, A Grade and U20 Men winning its THIRD successive premiership. This was strongly supported by the U16 men. It was also pleasing to see the Over 35 men winning their premiership. Making this a total of 5 championship pennants. What an outstanding achievement and commitment from our athletes, who gave their all to achieve this successful outcome – and in my opinion TTG has become the most successful club in SA.

Our youth competed well in the Sydney Nationals All Schools Championships with some athletes medalling and many achieving personal bests. Looking down the list of younger athletes, there is a lot to look forward to for TTG.

TTG men won the State Club Championships which was held early November over two nights, giving us the right to be the club to represent SA in the National Championships in Tasmania. At these Championships, we were well represented by a committed team, finishing 5th overall.

Again TTG was proudly represented in State Relays with great results over all age groups, men and women, with 14 gold, 7 silver and 4 bronze for track and 22 gold, 5 silver and 1 bronze for field. An outstanding effort.

TTG had a successful year behind the scenes, starting with many people volunteering to help at the City to Bay. This was a good opportunity to get behind the Club and soak up the atmosphere of this popular and growing event. We raised over \$1800 for the Club. A special thanks to Barbara, who worked in the City to Bay office, earning over \$700 for the Club.

The TTG Gift (pro meet) at Bulkana Oval was held on 18/2/07 and due to the hot weather, was subsequently moved to a twilight event. The day was a great success and being under lights, added to a great atmosphere. I would like to thank all of the sponsors who supported this event and a special thanks to everyone who helped on the day. These events would not succeed without their support. We received a lot of positive feedback from risiting athletes and officials resulting in the S.A.A.L. keen to re-book at Bulkana next year.
